# Chris McMichael

## NEW IN THE SHRINE

What do younger men and their families think of the Masonic Family, the Shriners in particular? How does the Shrine keep alive and thriving? Scrapbooks from 30 years ago show many different parade units and many marching Shriners. How will our great philanthropy survive into the future?

This question is being addressed by several of the newer and younger Shriners. When Nobel Chris McMichael inquired how to become a Shriner he was told he needed to become a Mason. His reply was, "What's a Mason?"

So began this young man's journey to become a Shriner. In 2013, he joined El Paso Lodge #13, where he currently serves as Junior Warden. He affiliated with #76 as well and has started his own membership campaign for his Lodges, knowing that is where Shriners and Scottish Rite members are born.

He got so involved with the Masons it took several years before he joined Al Kaly Shrine in 2015. He became involved in membership after meeting IS Jim Eaches and became inspired to reach out to other men his age. Nobel Chris and Joe Clendaniel have been appointed to the 2016 Membership Committee and for the past year had been hosting picnics at their homes until the attendance outgrew that venue. Now they are held every Sunday at the Mule Train facilities and are for prospective members and their families. Their numbers have grown from thirteen or fourteen to fifty-five recently. Their last outing at the Mule Barn brought thirty-two people.

Chris and Joe have been bringing the meat to grill at

the weekly pot lucks and they brought in a Bounce House recently for the children of the families who attend. What makes this unique is the wives and children are present and form friendships with the other families and allow those brotherhood bonds to grow in bonds of friendship and family ties. So far this year, they have generated twenty men who are already Masons or are in line to become Masons.

The Mule Train also provides an opportunity for members of the State Masonic Line and officers or members of other Masonic bodies to come, meet, and greet prospective members and their families. This recruiting tool can be used by units who are wanting to show off their units and perhaps help in the process of recruiting new members. Noble Chris also invited prospective members to the Super Bowl Party at the Colorado Springs Shrine Club. (We all remember that the BRONCOS Stomped the Panthers in that game and are the Super Bowl Champs!)

When Nobel Chris talked about how he views the renewal of the Shrine, he emphasized the brotherhood Masons experience as similar to the fellowship of comrades in arms for those men who have served in the military. By becoming involved with the Masonic fraternal organizations, men can recreate the feeling of support and loyalty present in their military lives. He felt younger men were attracted to an organization with men whom younger fellows could admire and emulate.

The lessons and the fellowship of Masons and Shriners give purpose and focus to their lives and ways to grow and become better men; for Nobel Chris it was a grandfather he admired and wanted to be like.

He knew about the Hospitals and all the good they do, but the first time he really knew about Shriners was when he went to one of their circuses. Grandfather was a Road Runner, or one of the men who would drive children and their parents to the hospitals for appointments. The good the Shrine does attracted him to become a Shriner, and of course, a Mason. As the Shrine and Masons move along into the 21st Century, the principles and the tenets that have lasted for centuries still attract the men who want to live good lives.

Keep the tradition alive. Aren't you proud to be a Shriner?







My Lady Mary and I thank you for your Support and ask you to remember Being a Shriner is Always Fun! (That's what we do!)







# Hospital News 2015 Summary

by *Phil Moss*

*Al Kaly Board of Governors Representative*

Although there are a lot of facts and figures in this article, I feel it is important you are made aware of the accomplishments of “your” hospital in Salt Lake City (SLC). Your donations thru the Temple, Clubs, Units, Daughters of the Nile and individuals, are what make it possible for our hospital system to survive and thrive.

- 1) The SLC hospital had a record year for 2015. The number of patients seen was 9,180 with 940 wait-listed for surgery. This is up 10.4% over 2014. Lead time for new orthopaedic appointments was down to from 33 to 22 days. Spine surgeries with implants was 68, a 51% increase. The total number of surgeries for 2015 was 952.
- 2) The year ended with Gross Revenues of \$36.1M. Our hospital third party collections amounted to \$7.9M which equals a 25% return; the system average is 19%. This will increase even more this year (2016) as we will be able to start billing for pharmaceuticals and other services.
- 3) Our Director of Donor Development, M.J. Miller and her team raised \$4.7M in 2015. The commercials you have seen resulted in a 13% upswing in donations system wide. Last year, only 6% of the public had heard of Shriners Hospitals for Children (SHC); in 2015, the

commercials resulted in a 23% recognition. SHC is now second only to St. Jude’s for name recognition and SLC has a lot to do with that.

- 4) For bragging rights, the SLC Tribune ranked our hospital as the 6th best midsize business to work for in the Utah area. Our hospital was ranked #1 among all SHC hospitals. And finally, along with the University of Utah Primary Children’s Hospital, we were ranked NUMBER 10 overall in the entire country for quality of pediatric orthopaedic care!
- 5) The rules for making donations did not change. I will reiterate; Temples, Clubs and Units may only direct donations to the SLC Hospital Travel Fund (money used to provide transportation of children from Mexico to the hospital for treatment) and to the Special Approved Capital Items. If your club or unit is interested in making a donation, you may contact me and I will coordinate or even better you may contact MJ Miller, Director of Development ([mjmillier@shrinenet.org](mailto:mjmillier@shrinenet.org) or 801-536-3567).





# Fundraising Activities

It is natural to associate the fez with Shriners Hospitals for Children. Because of this, meticulous attention must be given to all fundraising activities, including circuses, to make certain that such activities comply with the law of the land and that a contributor is not led to believe that his money will be used for the Hospitals when all or a portion thereof will be used otherwise. The integrity of our charity and of our fraternity must remain above reproach.

Your specific attention is called to the following fraternal and charitable bylaws:

**335.3 USE OF NAME “SHRINERS HOSPITALS FOR CHILDREN.”** The use of the name “Shriners Hospitals for Children” or reference to the Hospitals in connection with any fundraising activity by a temple or Noble without the written consent of the Imperial Potentate and the Chairman of the board of Trustees of the Hospitals is prohibited.

**503.10** The use of the name “Shriners Hospitals for Children” or reference to the hospitals in connection with any commercial product or business enterprise is prohibited unless the written consent of the Board of Directors and Trustees has been first obtained.

Now, therefore, IT IS HEREBY ORDERED:

## **1. Fundraising for Fraternal Purposes:**

No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated of

- a. An appendant corporation shall engage in any fundraising activity without the express written consent of the temple having jurisdiction thereof.
- b. There can be no representation, express or implied, that the proceeds will be for the benefit of Shriners Hospitals for Children.
- c. The temple potentate shall carefully examine all phases of the advertising, promotion and solicitation to determine that it complies with 335.3 and 503.10 of the fraternal and charitable bylaws.
- d. The temple potentate must approve the terms and provisions of any contract for a fundraising activity after receiving the advice of the temple attorney, and additionally, as may be required the temple bylaws.
- e. A copy of the temple potentate’s written consent shall be mailed to the Executive Vice President – Shriners International. Further, such written material pertaining to the fundraising activity, as requested by the Executive Vice President – Shriners International, shall

be promptly mailed to him.

## **2. Fundraising for Charitable Purposes:**

- a. No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations shall engage in any charitable fundraising activity other than for Shriners Hospitals for Children. Permission therefore must be first obtained in writing from the temple potentate. The temple potentate must then obtain written permission from the Chairman of the Boards of Directors and Trustees. This request for written permission shall be sent to the *Executive Vice President, Shriners International, P.O. Box 31356, Tampa, FL 33631-3356.*

However, a joint *charitable* fundraising activity with another 501c3 charity may be authorized provided that a minimum of 50 percent of the net proceeds are for the benefit of Shriners Hospitals for Children, and the chairman of the boards of directors and trustees determine, on a case by case basis, that it is in the best interest of Shriners Hospitals for Children and they grant their written permission for the activity.

- b. 100 percent of net proceeds (as defined in the *Charitable Fundraising – Approval and Reporting* provisions of this General Order) from charitable fundraising must be given to Shriners Hospitals for Children except for such portion thereof as may be permitted to be retained for the temple Shrine Hospital Patient Transportation Fund, pursuant to the *Special Purpose Funds* provisions of this General Order. Provided, however, if the Chairmen of the Boards of Directors and Trustees determine for good cause shown, that the law of the land requires that a portion of the net proceeds must be distributed locally, then they may, if they determine it to be in the best interest of Shriners Hospitals for Children, grant their written permission for such distribution.
- c. The temple shall report the results of each charitable fundraising activity within sixty days of the activity, pursuant to the *Charitable Fundraising – Approval and Reporting* provision of this General Order.
- d. This section shall not apply to activities exempt under 335.4b of the bylaws of Shriners International.
- e. Each independent corporation or entity that receives the permission of the Chairmen of the Boards of Directors

and Trustees to raise money for Shriners Hospitals for Children, and which does not have its financial statements audited pursuant to 334.5 and 337.8 of the bylaws of Shriners International, shall have its financial statements audited by a certified, chartered or licensed public accountant shall submit such audit report to Shriners International within 120 days of the activity.

**3. Statement of Purpose and Disclosure:**

- a. Every fundraising activity must contain factual information on its solicitation material, tickets, programs and documents, including electronically transmitted material, regarding the use of the proceeds.

*Examples: "Proceeds are for the benefit of (\_\_\_\_ Shriners) (\_\_\_\_ shrine club) Activities."*

*"Proceeds are for the benefit of Shriners Hospitals for Children."*

- b. Every fundraising activity which is not entirely for the benefit of Shriners Hospitals for Children shall prominently state on the solicitation material, tickets and documents that "payments are not deductible as a charitable contribution."
- c. There must be compliance with the *Revenue Act of 1987* provision of any existing general order by U.S. temples.

**4. Compliance with Applicable Laws:**

It is the responsibility of the temple potentate, after receiving the advice of the temple attorney, to determine

that there is compliance with all applicable laws in its jurisdiction for the temple's fundraising activities.

**5. Financial Records:**

- a. The temple shall maintain detailed financial records pertaining to all fundraising activities involving nobles, clubs, units, organizations of nobles or affiliated or appendant corporations. Details of all revenues and expenditures shall be maintained in such financial records.
- b. The temple must retain such detailed financial records for a period of seven years.
- c. There must be compliance with *Financial Reporting on Charitable Funds and Activities* provision of any existing general order.

**6. Notification of Nobility:**

A copy of the Fundraising Activities provision of this General Order shall be printed in the temple publication at least once every calendar year. If there is no temple publication, then a copy shall be mailed to each Noble in the temple not later than the last day in March of each calendar year.

**7. Discipline:**

Any officer, Noble or temple which violates a provision of *Fundraising Activities* is subject to discipline pursuant to the bylaws of Shriners International.



# AL KALY MULE TRAIN

A number of years ago I was visiting family members in New Mexico and after church services one Sunday morning, the pastor named Mike, a cousin of mine named Bob, and I were standing around “visiting”. The preacher owns horses, Bob has owned mules for forty years or more, and I, of course, own a mule. So naturally and predictably, the conversation turned to horses and mules.

“How do you get a mule to do what you want it to do, Bob?” the preacher asked. (I always wondered if the question wasn’t really about how to make his congregation behave themselves.)

Bob, a big beefy man, but not huge, has red hair going gray and a large red moustache, not yet going gray, pasted in the middle of a ruddy face and freckled hands as large as a mule’s hoof. He raised one hammy hand, extended a sausage index finger, and said in his soft-spoken way, “Rule number one, make it easy to do the right thing.” A second sausage finger joined the first. “Rule number two, make it hard to do the wrong thing.”

*Rule number three*, I thought, *is patience with the big animals*. He didn’t add that one, I believe, because to him, it is simply understood.

A number of years later, Gale Fortney told me if I wanted a mule to behave, all I had to do was make the mule believe it was his or her idea. *All I had to do. Ri-i-i-ight! Ok*, I thought, *that’s now rule number three and patience is rule number four*. Believe me, I had plenty of opportunities to test the rules. And the mules had plenty of opportunities to test me.

A few years ago, Torry Krutzke and I rode on the Colorado Mule Riders ride and had trailered our mules together. That year we rode at the Elk Mountain Ranch near Buena Vista. The last day, a Friday, all 35 of the riders had enjoyed a great breakfast and walked out to our animals, trucks, and trailers to begin the drive(s) back home. We put a little feed in the feed shelf of the trailer and, amid the sounds of truck and trailer doors closing, and the sounds of some last goodbyes, we went about the task of loading our mules for the ride home.

I led Maggie to the rear of the trailer and she spied the feed immediately. In she went. *Her idea*. She is always ready to eat. So all three rules applied: *Easy to do the right thing*; for her eating is easy; *Difficult to do the wrong thing*; for her not eating is difficult; *Her idea*; It’s always her idea to eat. In fact,

she likes to eat so much, she might be described as robust. . . er. . . maybe rotund is the better word. I tied her with a short lead; long enough to give her some slack, but not enough slack for her to try to turn around and get in trouble.

Torry then led the big mule, Denver, to the rear of the trailer to load him next to Maggie. He stepped up tentatively and stopped with both front feet on the edge of the trailer. *Definitely not his idea to step into the trailer*. It seemed a little too dark and scary. So we set about implementing rule number one: Torry looped the lead rope through the tie-off ring in the front of the trailer, which happens to be next to the feed shelf. He then stepped out the escape door and put some of his weight into pulling on the rope. That gives the human a little advantage because it allows for leverage, more or less like a pulley, to use against the mule. Torry maintained pressure on the rope. *That makes it easy for Denver to move forward; difficult to move backward*. I stood behind Denver, encouraging him to climb into the trailer. I whacked him lightly on the rump, talked to him with encouraging words, pushed him a little, all to no avail. This went on for several minutes. Torry and I exchanged places – I pulled on the lead rope – Torry took up a spot behind Denver to encourage him to move forward.

Fifteen minutes in, I noticed the ranch had gotten incredibly quiet. **All** the other riders had departed and were well down the road. I idly wondered where the staff and ranch hands were. Working inside, I assumed. Here we were beneath a bright blue cloudless Colorado sky trying to get a recalcitrant mule to load into a dark trailer. *Who says mules are stubborn?* The only sounds were those of Maggie happily munching her grain, Torry and I breathing a little harder than normal from our exertions, and an occasional “C’m on Denver, get in there.” *There are much worse ways to spend a Friday morning*.

We worked, talked, sweated, cajoled, and bribed, but nothing would move the big mule. Finally, forty minutes later, Denver decided it was his idea to load. He stepped up into the trailer like there had been no problem whatsoever and had a bite of grain. I quickly tied him with a short rope. Torry wasted no time closing the trailer door.

I hopped into the driver’s side of the truck; Torry hopped into the passenger side. I closed my door, cranked up the engine and rolled up the window. I looked over at Torry and grinned. He grinned back. I pulled the gearshift lever into the D position, and with our live cargo in mind, eased down on the gas pedal to begin the drive home.


